EXPANDING HEALTH SERVICES



The Ministry of Health branch in Gash Barka region reported that strong effort is being made to expand health service provision in the region as well as to develop human capacity and introduce modern medical equipment.

Indicating that public-awareness on communicable diseases has increased as a result of the integrated effort in cooperation with partners, Dr. Hayelom Kidane, head of the ministry branch in the region, said that priority will be given to qualitatively improve the provision of health service.

Ms. Amina Nur-Husein, Minister of Health, on her part noted that with the growing demand of health services, utmost priority is being given to upgrade the professional skills of health practitioners and supply of medical equipment.

Mr. Abraha Garza, Governor of the region, on his part expressed readiness of the regional administration in the effort to provide quality health service to the public.

ENHANCED AWARENESS ON CORONAVIRUS

The Ministry of Heath has urged citizens to enhance awareness on Coronavirus outbreak that was detected in the Chinese city of Wuhan and spreading rapidly to other countries.

Speaking to Erina, Dr. Andebrhan Tesfatsion, said that the Coronavirus causes acute respiratory infection and there is no specific cure or vaccine. Dr. Andebrhan indicated that the common symptoms of the disease are headache, fever, runny nose, cough or sore-throat and muscle pain among others.

Pointing out that the virus could be transmitted from person to person through coughing and human contact; Dr. Andebrahan has advised the whole nation to frequently clean hands using alcohol or soap and water, cover mouth and nose while sneezing as well as other means that could prevent the virus from infecting.

According to report, Dr. Andebrhan said that the virus within two weeks has been detected in the US, Australia,

France, Canada, Thailand, South Korea, Japan, Taiwan, Singapore, Vietnam and Germany. He also went on to say that according to report from the Ethiopian Ministry of Health, five individuals suspected of being infected by Coronavirus have been placed in isolation.

Dr. Andebrhan also noted that the Ministry of Health in collaboration with partners is carrying out rigorous screening on passengers at the Asmara International Airport, has established quarantine center at Villaggio Community Hospital and is advising nationals that are in China for various reasons to contact the Eritrean Embassy in that country.

A Glimpse at Foro Sub-zone

Foro sub-zone, which was riddled with challenges during the colonial times, has been a site of development activities. This is just one example of the development ventures throughout the country. So, having a glimpse at Foro subzone is just sharing a visible picture about the endeavours being made to improve the living standards of all nationals.

Being one of the 10 sub-zones of the Northern Red Sea Region, Foro sub-zone borders Massawa to the north, Gelalo sub-zone to the southern east, Ghinda'e subzone to the northern west and the Southern region to the west. The total area of the sub-zone is 2,770 square km that are grouped in 15 administrative areas and has a total population of 44,000.

Most of the residents, 89%, of the sub-zone are farmers and pastoralists while 11% live on fishing and trade. The sub-zone is home to five ethnic groups: Saho, Tigre, Afar, Tigrinya and Rashyda. What is more, the historic site of Adulis, Erafayle's hot spring and amazing remnants of volcanic eruptions are some of the assets of



the sub-zone.

A strategic Egila-Foro road is the best example of the efforts that are being exerted to connect all areas of the country with viable roads and transportation systems.

The sub-zone has an even distribution of schools in 14 of its 15 administrative areas. Apart from kindergartens, the sub-zone has 40 schools ranging from primary to secondary that have been serving 4,000 students, 33% of whom are girls.

Although schools have been built in remote parts of the sub-zone, enrolment has been few. "Even

though promising outcome has been registered, nomadic lifestyle has been the main challenge. The number of students attending schools has been few compared to the availability of schools," said Mr. Osman Arafa, Administrator of Foro sub-zone.

Also, according to Mr. Osman, some students have not been able to pursue their junior schools due to lack of such facilities in their vicinity. To alleviate such challenges a boarding school needs to be established in the areas where such problems are prevalent. healthcare services and collaborate with healthcare professionals. Maternity service has improved with more mothers attending prenatal and postnatal services.

The role of healthcare professionals in raising awareness

to give vaccination. As a result, there was 98% immunization coverage in 2019.

The sub-zone has registered remarkable progress in environmental hygiene, Mr. Osman said. Environmental protection has been carried out at community level. Encouraging outcome has also been registered in the eradication of FGM and other harmful practices that affect women's health.

Transport service has been one of the major developments in the sub-zone. Residents have been benefiting from ample services being provided via Masswa-Assab and Foro-Adi-Keyih routes. Other commercially strategic roads include Foro-Zula, Foro-Malka, Foro-Aligede and Foro-Robrobia.

The areas along Massawa-Foro and Adi-Keyih-Omarkabre routes have regular transportation service while the other areas have weekly services on market days.

The residents of the sub-zone also benefit from telecommunications service that has been provided in most areas that are equipped with such facilities. Solar powered public telephones have been installed in Foro semi-urban centre. CDMA service has also been provided in some areas. "I am very optimistic that expansion of telecommunication services to the remote areas will be implemented as soon as possible," Mr. Osman Dnango, Gebgeb-Wasana and some parts of Ayromale and Malka administrative areas are dependent of streaming water for their day-to-day activities. Villages situated on plain land -- Robrobia, Gereleinde, Lehazien, Afta, Zula, Kadra, Erafayle and Ayromale -have access to potable water from the solar-powered distribution facilities.

Soil and water conservation activities have been carried out to enrich underground water resources in some areas. Water dams have also been constructed. Farmers in Foro sub-zone grow maize, sorghum some fruits and vegetables. The sub-zone has a total of 8,300 hectares of farm land that depend on seasonal highland and lowland rainfall. Wegenbo farm area is the bread basket of the sub-zone.

The soil and water conservation activities that have been carried out in the sub-zone include the construction of terraces, microdams and water reservoir tanks.

The sub-zone is also endowed with varied species of wild life including Ostrich, wild Ass and antelope.

Mr. Osman advises the residents of the sub-zone to make maximum use of the marine resources, particularly those who live around the coastal areas. Regrouping of villages giving utmost focus to the nomads living in scattered areas

Marriage, Family and Country

Marriage is one of the few things that do not require actual experience to know their benefits. Being the product of marriage alone gives one the right to speak about marriage. The purpose of this article is to highlight the importance of marriage in the creation of strong families and country.

Marriage is one of the most celebrated, honored and valued cultural institutions in Eritrean society. It is considered a source of supreme fulfillment and happiness. Traditionally, in the Eritrean society marriage is viewed as a requirement for adults to join the community of families. Marriage is every one's business. When you reach a certain age your acquaintances often try to persuade you to get married.

The customary laws of Eritrea that shaped the legal, socio-cultural and intellectual life of the Eritrean society have invested great interest in marriage. The details of the ceremony and content of the marriage contract are clearly stated in all the customary laws of Eritrea. In the Eritrean society marriage is not an affair of the couples only; it is a familial, communal and societal affair. Traditionally, marriage is meant to create a bond and lasting relationship between families. The marriage is usually celebrated a long time after betrothal. The betrothal, as the solemn exchange of promise, is the first act in the celebration of marriage.

The coming together of a man and a woman in marriage creates the greatest companionship in this



and stable marriage between a responsible man and woman. A Child is the greatest gift to a family and country. Children are the sons and daughters of a country and its citizens. If we are concerned about the future, then we must look at the way children are raised today. The best way to protect and support children is to protect and support marriage. Therefore, marriage should be encouraged, supported and protected in every possible way. Eritrea became a signatory to the international Conventions on the Rights of the Child (CRC) as early as 1994 following its independence. As one of the first state signatories to the Convention on the Rights of the Child, Eritrea remains fully committed to its operationalization. The new civil and penal code of Eritrea has many good qualities in relation to the rights of a child. Art 567(1) of the civil code specifies that "the spouses shall cooperate ... to ensure the moral and material direction of the family, the upbringing of the children and the preparation of the children for their place in society".

The greatest resource we have lies in the families that produced children. The national charter of Eritrea (1994) recognizes the strength and quality of our nation's families that will determine the development of our nation. It states that "Our vision is for Eritrea to preserve its identity and uniqueness, develop commitment to family and community care...". Therefore, if the quality of a family has the power to determine the success of our nation, then the marital quality will determine our nation's destiny. For this reason, marriage needs full legal protection. In Eritrea, two kinds of marriages are legally approved and protected. Marriages may take place before a civil-status officer or in accordance with the religion or local custom of the parties. In both forms of marriage a man and a woman who are below eighteen years of age are not allowed to enter the contract of marriage.

Eritrea has sufficient human and material resources for its development. However, a nation is built on and secured by values other than these resources. The family is the first place where values are acquired, nurtured and transmitted. The first task of the family is to be the first good school where a child learns important social values. The family is the first school in Eritrea to teach and pass on our rich cultural heritage and the progressive values developed during our liberation struggle such as love of country, respect for humanity, solidarity between men and women, love of truth and justice, respect for law, hard work, self-confidence, self-reliance, open mindedness and inventiveness. A

healthy and stable marriage is the key to the formation of a viable nation. A healthy marriage adds important ingredients to nation building, peace and prosperity. Our country becomes great only by the efforts of stable, responsible and faithful men and women.

Good marriages are the bedrock of strong societies, for they are the foundations of strong families. The strength of the nation depends on the strength of its families and the strength of families depends on the strength of marriage. So the quality of marriage has an upper hand in influencing the success of a nation. Therefore, the society and the government must promote and defend marriage and the family from every possible misrepresentation of their true nature.

The right to marry and found a family is affirmed in the Universal Declaration of Human Rights (1948). Article 16 (1) states that 'men and women of full age, without any limitation due to race, nationality or religion, have the right to marry and to found a family'. Eritrean customary and modern laws also affirm the truth that marriage is a life-giving union of a man and a woman. Chapter 5 of the new penal code of Eritrea condemns the offences against marriage and the family. Fraud and deceit in marriage are severely punishable crimes in Eritrea. Whether we like it or not the future strength of Eritrea will depend on the quality of the present marriages and families. The religious and political communities as well as the society as a whole have to bear their responsibility adequately to honor and protect marriage and family and ensure their sustainability.

• On Jan 31, 1975, EPLF & ELF launched an attack on Asmara. A number of battles in nearby villages & on the outskirts of the city were fought. The Ethiopian/Derg government soldiers went on the rampage through Asmara & surrounding villages as retaliation and killed hundreds of civilians.

• On Jan 29, 1952, the United Nations General Assembly (UNGA) adopted Resolution A/RES/530 on "Economic and financial provisions relating to Eritrea." The Res. decided that Eritrea shall receive, without payment, the movable and immovable property located in Eritrea owned by the Italian State.

The property the UNGA referred in this Resolution included; -The public property of the State; -The inalienable property of the State; -The property of the Fascist Party and its organizations -The alienable property of the State; The property belonging to the autonomous agencies (aziende auto-nome) of the State which are: -Ferrovie dell'Eritrea -Azienda Speciale

Approvigionamenti -Azienda Miniere Africa Orientale (AMAO) -Azienda Autonoma Strade Statali (AASS);

The Res. stated that it did not restrict the right of the Admin Power (Britain) to make, during the period of its admin, such dispositions of property whether limited to that period or otherwise, as may be required by law or may be appropriate for the good government. ... of the territory, or may be necessary for the implementation of the present resolution. However, the Resolution did not give Britain the power to dispose what the British Mil Admin disposed between 1941 and 1952 which is worth around 3 billion pounds in today's value.

The UNGA Res required Italy to continue to be liable for the payment of civil & military pensions or other retirement benefits earned as at the date of coming into force of the Treaty of Peace with Italy and owed by it at that date.

On Jan 26, 1943, a US War Department Disposition Form was issued for the establishment of a War Department Fixed Radio Station in Eritrea and Kagnew Station was opened. The US spent 77 million USD to build the Station. Kagnew Station was originally an Italian naval communications center. In 1941, the British took over the center from the Italians and gave the naval station to the US and the US used it as a naval station at first. The Base was redesignated the 4th USASA Field Station in 1958. Kagnew Station was used to monitor nuclear explosions in the Soviet Union & was a good relay station for the military system across the world because of its location. It had provided the communists relay for Kissinger's early trips to China (1st the secret mission) and then the Nixon visit. It had the capability to

communicate directly to Beijing from Asmara and then relay to Europe and then to the US. The rock-and-roll programming on Kagnew's 1,000-watt AM station was heard as far away as Australia, Finland and Brazil.

At its peak in the mid-1960s, there were 6,500 Americans at Kagnew Station in Eritrea with massive operation with 13 sites. It did telecommunications relay and tele-intercept work. It had huge dish antennae that were some 80 feet across.

In April 1977, Derg's Mengistu ordered the expulsion of several Americans in Eritrea and Ethiopia and the closure of Kagnew Station by April 29. Over time the US paid Ethiopia more than \$360m in military aid as rent for Kagnew, billions of USD in today's value.

Congratulations on your win!

Thank you! Congratulations to us all. This is a trophy for the nation.

It is indeed. How has the people's reaction been since the news broke out?

Huge! It has been some humbling couple of weeks for me and the team involved in the making of our short film, 'The Bad News'. Everyone is proud of the nomination and local filmmakers as well.

Tell me, please, about this specific work. What was the inspiration for the film and what is it about?

It started as a poem that I

wrote in 2003. I later on posted it on my social media page and had a number of comments that inspired me to transform it to a short film. It is about a man who is about to commit suicide but he doesn't want to bother anyone. So, he bought his own casket, paid for his burial ground and even bought a bouquet of flowers for his funeral. He was also a type that would normally buy lottery tickets. He bought one as his last souvenir.

He saw the prize money of 500,000 and didn't bother even to look. But as lady luck works in mysterious ways, when he hanged himself and people rushed to help they noticed that he had actually won the lottery.

Let's speak on the technical aspect now. In these 35 minutes you tell a life story of a man who tried to beat life in every aspect but never had anything good happen to him till he won the half of a million he didn't have a chance to get the prize money. This man raises a philosophical approach related to death as well. He dies gloriously after personally setting his own funeral before he even died. How did you manage to tell the story in 35 minutes and still keep the depth of it, using obviously limited resources?

We first filmed it to last one hour and a half. But then the idea of entering a competition had us work on the film all over again. The requirement for the IndieFEST Short Film Awards and most of the prestigious film awards is 30 minutes minimum and almost one hour maximum. Our aim was to present our film according to known standards. Film making is all about team work; so if I am to answer how we maintained the depth of the story in that amount of time and our limited resources, I would say, it needed the creativity, talent and goodwill of everyone involved.

What made you think that the movie was worth a shot for IndieFEST?

I would say the urge of having recognition for our work. Normally our products are meant for our local audience. Trying to enter the competition with this specific short film meant testing ourselves in a bid to learn what the international public thinks of our technics and our stories. Filmmaking is a language that needsnotranslations. Filmmakers,

actors, editors and others know what cinematic language a movie uses just by looking at one. So I can say that we have been very eager to have our movies read and understood by professionals like us to ultimately know where we, Eritrean filmmakers, stand. We keep in touch with films from around the globe. We follow international awards starting from BAFTA to ACADEMY awards and more. After the film was made, we knew, at least we hoped, that our film too was well made and, therefore, capable of communicating with the world through the cinematic language filmmakers use worldwide. That being said, our main goal was to simply test ourselves.
