

PRESIDENT ISAIAS AFWERKI HOLDS EXTENSIVE DISCUSSION WITH PRESIDENT OF SOMALIA



President Isaias Afwerki and President Hassan Sheikh Mohamud of the Federal Republic of Somalia held extensive discussions at the State House on 8 July focusing on strengthening

bilateral ties and other matters of mutual interest.

President Isaias invoked the

historical ties between Eritrea and Somalia and emphasized the imperative of consolidating robust and all-rounded bilateral relations that advance the interests of both peoples, especially in the political, security, military, economic, cultural, and social sectors.

ASMARA TECHNICAL SCHOOL GRADUATES 93 STUDENTS

Mr. Elias Woldegebriel, the director of the school, indicated that the training covered basic music theory, the history and development of music, an introduction to voice and music synchronization, and instruction on 13 types of musical instruments, including seven modern and four traditional instruments.

TRAINING ON PRODUCING ORGANIC FERTILIZER

Greatly Enriching Communities and the Nation as a Whole

There are more young people in the world today, estimated at between 1-2 billion people, than at any other time in history. Not only do young people account for a large proportion of the world's population, they also represent powerful agents of positive change and continue to be drivers of socioeconomic growth and development.

Role of youth in growth and development

It is now well known that when young people participate meaningfully in the economy and wider society, there is greater socioeconomic growth and

the centrality of youth to broadbased development and societal transformation is the prominence of place of youth within the United Nations (UN) 2030 Agenda for Sustainable Development. Ensuring the health, well-being, and rights of children and youth, as well as reaching those who are the furthest behind, is a prerequisite for achieving the 2030 Agenda and the Sustainable Development Goals (SDGs). More than one third of the UN's SDG targets reference young people explicitly or implicitly, with a focus on empowerment, participation, and well-being, while paragraph 53 of the UN's 2030 Agenda declares, "The future of humanity and of our planet lies in our hands. It lies also in the hands of today's



societies tend to be more cohesive. Additionally, youth tend to be extremely critical, inquisitive thinkers and they have the capacity to expose contradictions and biases, many of which are often completely overlooked or ignored by other segments of the population. At the same time, due to their boundless creativity and seemingly limitless enthusiasm, young people have the potential to offer fresh perspectives and propose or develop innovative solutions.

Commitment and policy

Eritrea is richly endowed with various natural resources. Home to a number of different ethnolinguistic groups, it boasts a colorful blend of beautiful cultures, and lively, vibrant diversity. The country's long, pristine shoreline on the Red Sea holds significant potential for the establishment of a thriving blue economy, while its geo-strategic location, positioned along one of the world's most important international maritime shipping routes, offers boundless opportunities to become a major transshipment and logistics hub. Furthermore, Eritrea's rich biodiversity, abundance of unique socio-cultural and historical sites. untouched islands, and favorable climate, combined with its relative peace and security and the general warm hospitality of its people, present fantastic possibilities for a thriving tourism sector.

advantages, however, Eritrea's people, particularly its youth, are undoubtedly the country's greatest resource and most precious asset. This has been articulated and explained in national documents, as well as by government officials. For instance, the country's National Charter, which was adopted in Nakfa in 1994 and outlines the guiding vision for the nation, declares that, "Our greatest asset is our human resource."

Moreover, in a 2022 voluntary national development report that was submitted to the United Nations, Eritrea's Minister of Information, Yemane GebreMeskel, explained that, "the Eritrean government's policy is and has always been firmly centred on investing in human capital and youth, which are, without question, our most important resource and greatest asset."

The country has long worked for the fulfilment of child and youth rights and the reduction of their vulnerability in society. The first international convention ratified by the Eritrean government after the nation won its independence was the Convention on the Rights of the Child (CRC), while it also acceded to the African Charter on the Rights and Welfare of the Child (ACRWC) in December 1999, not long after the Charter formally entered into force – thus reflecting the very high priority accorded to promoting and protecting child and youth rights, well-being, and development. Children's legal rights, freedoms, and protections are set out in national law and policies, while a national child policy document, which will further safeguard and promote the rights and general well-being of children, is in the process of drafting and finalization.

initiatives put in place to help address their underlying causal factors.

Of note, orphans, vulnerable children, and at-risk young people receive a broad range of support through the Ministry of Labour and Social Welfare (MLSW), different organizations, and governmentsupported host families and group homes, which protects them from a multitude of risks and helps to improve their standard of living. Several nationwide youth groups and associations, particularly the National Union of Eritrean Youth and Students (NUEYS) and the National Union of Eritrean Women (NUEW), exist to empower youth and children, provide them with the necessary skills, support and opportunities needed to reach their potential, and offer a platform through which their voice can be amplified and their engagement advanced. They also serve to celebrate the country's rich ethnolinguistic diversity and promote mutual understanding, civic engagement, national cohesion, and unity.

Multifaceted contributions

Over the decades, young people in Eritrea – of all backgrounds and hailing from all of the country's regions – have contributed immensely and in myriad ways to the nation's development and progress.

Within the education sector, for instance, young Eritreans serve as teachers in communities across the nation, helping to propel the country's significant progress in literacy and enrolments, as well as expand its human capital, while the country's young health professionals administer care to people of all ages in all corners of the country, improving not just the health of individuals but the well-being of the entire Additionally, young nation. Eritrean graduates in a number of fields conduct pioneering and highly impactful research, as well as develop innovative solutions to improve lives and promote progress in a variety of sectors, such as agriculture and engineering. Late last year, during an extend trip to Eritrea, Akinwumi Adesina, President of the African Development Bank, positively noted the contributions of Eritrea's young engineers to the

country's infrastructure.

Young Eritreans are also contributing to the nation's significant climate change adaptation and mitigation efforts, particularly through their active participation in community greening campaigns, water conservation projects, and similar initiatives. As well, young Eritreans continue to play a prominent role in raising awareness and changing harmful, deeply embedded norms associated with important social issues, including those related to gender equality, disability, and mental health.

Notably, the local music, arts, fashion, and cultural scene in Eritrea is brimming with top talent and offers countless examples of young people's remarkable creativity and imagination. Sports, too, are an inspiring showcase of young Eritreans' distinction and excellence. Alexander Isak, playing in the English Premier League, perhaps the best in the world, just completed a fine season - which has led some of the world's best clubs to express interest. Of course, at present, Eritreans – and many others across the world - are watching intently and proudly as Biniam Girmay continues to make history in France in the world's most prestigious cycling competition.

Of course, in addition to everything else they have accomplished and contributed, young people in Eritrea have remained at the forefront of defending the country's territorial integrity and protecting its hardwon sovereignty. Doggedly committed to their sense of patriotic duty, they have heroically foiled years of external aggression and various efforts to roll back independence.

Furthermore, young people play a positive role in tackling a wide range of issues through advocacy, lobbying, volunteering, or their leadership of and active engagement in communitybased or civil society initiatives. Alongside all of the above, a large body of compelling research conducted in countries around the world has affirmed the capacity of young people to build bridges of healing and reconciliation within post-conflict settings.

We [Eritreans] knew Bini would win another stage and that he did. His second of the tour. Although he graciously attributed this win to the unwavering support of his parents, this win in essence was perhaps a powerful rebuttal to his doubters. This was a show of masterclass in tactical nuance seamlessly interwoven with brute force, which would have you think Biniam was a seasoned rider at the Tour De France, not a cyclist participating in only his second Tour. This stage win was more than just another stage victory; it was a statement.

On a somber afternoon for cycling, when André Drege tragically lost his life in the Tour of Austria, the event served as a stark reminder that beyond any competition, these are human beings. Yet, Biniam Girmay's final sprint, which saw him, beat Jasper Philipsen, a four-time stage winner last year, to the finish line, left spectators once again in awe. You couldn't be faulted for pausing for a second to ask yourself if he was indeed a mere mortal like the rest of us.

During the final stretch, Bini found himself caught behind an early attack by Bryan Coquard. Initially boxed in toward the finish line, Philipsen sprinted past both Bini and Coquard in the final few hundred meters. However, Bini made a final surge, taking the win on the line.

Reflecting on the win Biniam expressed his gratitude to his parents: "I think this victory I need to give to my mother, to my father. They believe in me. They gave me all the support to become a cyclist, to become a professional and yeah, I just want to say thank you very much to my family. So proud." Adding that the little uphill in the final kilometers played to his favor. "I prefer this kind of sprint because if it's really flat, the other guys are bigger than me and heavier so they can push more watts, so they can go faster. But these finishes for me, with my weight, super nice."

The lead out by his team was perfectly timed, having paved the way for him to secure 17 points in the intermediate sprint in Lamargelle and subjecting Philipsen to 4th which helped Bini extend his points classification to a whopping 216 points; in the last kilometer Intermarché - Wanty took over, guiding Bini to position himself expertly for the final sprint. Although, Bryan initiated his sprint early, he was overtaken by both Jasper and Bini. In the final few meters, it was down to two sprinters,



Biniam and Jasper.

In the end, Biniam was just too good and too fast for Jasper. As he crossed the line, there was an aura of undeniable confidence in Bini. In the last turn before the bunch sprint, it seemed clear to him that he was going to win this stage. There was no overthinking, no feeble attempt to breakaway early like Coquard and Philipsen did. This was a rider in his element, unfazed by being the only black African rider in the tour, in retrospect he actually seems to revel in the moment.

"The team put me in the perfect place. They have me a good lead out; I just felt super good," he stated after the race. sustained excellence and another win on stage 8 over the weekend is what makes his second victory even more remarkable. It is a story of resilience, determination, and the pursuit of greatness – qualities that define champions.

His second stage win in this tour de France is crucial because it demonstrates consistency. Winning a single stage could be obliviously attributed to a fortunate moment or a favorable situation, as some have done with Bini's first stage win. However, winning a second stage and retaining the green jersey – which requires consistent performance across multiple stages – speaks volumes about Bini's abilities. It is a testament to his skill, endurance, and strategic prowess.



Biniam is not a superstar in the making; he already is a superstar. The Eritrean is not only the first black African to win two stages; he is also the first repeat winner of this tour de France and that is a proper super star.

After his first stage win this past Monday Bini said, "We must be proud. Now we are part of the big races and have success. Now is our moment, now is our time. This for all Africa."

Eritrea Marks World Day to Combat Desertification and Drought

The commemorative ceremony witnessed the presentation of local research papers on diverse, relevant topics and a panel discussion on the national context of the Theme of the Day.

The 17th of June is World Day to Combat Desertification and Drought, observed globally. This year, the Day was internationally observed in Bonn, Germany, for the 30th time under the theme "United for Land: Our Legacy. Our Future."

In Eritrea, the commemoration of the event, which was organized by the Ministry of Agriculture (MoA), took place on the 18th of June in Asmara, National Confederation of Eritrean Workers' Hall and was attended by around one hundred participants, including senior MoA officials, representatives of relevant line ministries, regional administrations, national associations, higher educational institutions, the United Nations Development Program (UNDP) office in Eritrea, FAO, stakeholders from several development programs, agriculture experts and farmers, among others.

Delivering a keynote speech at the event, representing the MoA, Mr. Semere Amlesom, the Director General of Agricultural the Extension Department of the ministry, stated that the annual event calls for everyone to enhance participation in the endeavors being exerted towards restoring degraded land and combating desertification to leave safe land to subsequent generations. Pointing out that the livelihood of more than 3.2 billion people of the global population is at stake due to desertification, land degradation, and drought, he explained that the most vulnerable people constitute rural agrarian communities and small-scale farmers and that the dire consequences thereof are poverty, hunger, unemployment, and migration. Mr. Semere further indicated that soil and water conservation, as well as afforestation programs, are being pursued as the cornerstone of national strategic policies and called for stepped-up and integrated efforts on the part of pertinent bodies, including members of the national defense

forces, local communities and experts for a more impacting outcome in this area.

Speaking on the occasion representing the UNDP office in Eritrea, Ms. Nashida Sattar, the Officer in Charge of the office, said, "We are aware of the considerable resources and strong community participation invested by Eritrea pursuing soil and water conservation, construction of water reservoirs, enhancement of agricultural productivity, and sustainable land management." Ms. Nashida went on to indicate that the occasion serves as an opportunity to discuss and recognize Eritrea's human-led solutions that were put in place to adapt its capacities since independence and that the Government of Eritrea, through its legislative as well as policy frameworks, has been playing an active role in solidifying its engagements to this effect. She also reiterated the UNDP's readiness to enhance partnership and support in the efforts Eritrea is putting up towards ensuring long-term resilience and environmental and social justice.

Moreover, five thematically relevant research papers were presented on the occasion, preceded by a question-andanswer session.

Crime and Consequences: Mr. Tesfay Ogbay Educates Eritrean Youth through Fiction

Thank you for your time, Mr. Tesfay. Can you tell us about your background as a writer?

Thank you! Regarding my writing background, I had no literary influences or experiences from my family. My literary journey began during my school days at Asmara Hafeshawi Secondary School. The school fostered a vibrant culture where students regularly presented poetry during brake times. In this environment, I first felt drawn to the world of literature. Finishing High School at Hafeshawi, I went to Sawa with the 5th round of national service. Sawa provided a remarkable platform for personal growth and exploration of talents. There, I truly began expressing myself creatively, writing short stories, poems, and even composing melodies. After completing national service, I took on the role of a police officer. This experience and my literary background led me to contribute to the "Hadas Ertra" newspaper. I actively participated in various programs related to writing and cultural expression. I pursued multiple courses, including theatrical

Mr. Tesfay Ogbay is the author of the crime fiction "Katiena". Last week, he launched his second crime fiction, "Ab Shela". Tesfay also regularly contributes to numerous literary works, including preparing a sports page for the Sunday publication of Hadas Ertra newspaper and serving on the board of writers for the bimonthly police magazine "Hzbn Polisn".

National Union of Eritrean Youth and Students (NUEYS), these programs offered a ground for young Eritrean talents. Participating in "Meadi Snetbeb" was an enriching experience. It provided a unique opportunity to collaborate and learn from other talented young people, further broadening my artistic perspective. The program provided a valuable foundation as I began writing my first book, "Katiena," which I launched in 2014. This allowed me to continue improving my writing and narrative skills.

What inspired you to create this sort of crime novel?

My debut novel, "Katiena," was born out of the unique confluence of my experience as a writer and police officer. It's a fictionalized crime story centered on three friends. Two of them become entangled in a suspenseful criminal act, and the narrative explores the consequences of their choices. The core message of "Katiena" is one of accountability: it underscores the idea that wrongdoings, no matter how cleverly masked, will ultimately be revealed. This kind of crime fiction was a novelty in Eritrean literature, and the positive reception from readers was a tremendous encouragement. "Katiena" became a cornerstone of my literary journey.

Ten years after "Katiena," I'm thrilled to be launching my new book, "Ab Shela." This novel explores a different theme: the lasting impact of a strong upbringing and the family's role in shaping a child's character. However, it also delves into the complexities of trauma, particularly the assault a woman might experience. As a police officer and long-time member of the Eritrean Police PR department, I've been exposed to countless reallife criminal stories, some genuinely shocking. These experiences and the opportunity to write real-life crime stories for the "Hzbn Polisn" magazine fueled a desire to create something more impactful. Daily exposure to the social consequences of crime ignited a passion within

me. I wanted to go beyond simply reporting; I craved a way to educate and inspire, particularly the youth of Eritrea. "Katiena" emerged from this desire. Through a fictionalized narrative, I aimed to reach young people and teach them valuable lessons:

My background reinforces my belief in the family as the bedrock of a strong nation. A healthy family fosters a healthy society, producing a productive and responsible citizenry. This novel represents my contribution to building a more informed and responsible generation in Eritrea.
