ERI-DIASPORA ENGAGES IN VARIED PUBLIC DIPLOMACY ACTIVITIES





Eritrean nationals residing in Italy, the Netherlands, Sweden, and the USA actively participate in extensive public diplomacy activities, including seminars, conferences, and celebrations.

According to a report from the Public and Community Affairs Office in Italy, seminars were held from 14 January to 28 April in 11 cities, including Abruzzo, Florence, Padova, Torino, Bologna, Napoli, Bari, Catania, and Palermo. These seminars, which were of significant importance, saw the participation of over 2,000 nationals. At these events, the Eritrean Ambassador to the Republic of Italy, Mr. Fesshazion Pietros, and diplomats from the Eritrean Embassy delivered briefings focused on strengthening the resilience and organizational capacity of the 4th Front. They highlighted the noble values and resilience of the Eritrean people in achieving independence, safeguarding sovereignty, and countering external conspiracies, and called for enhanced participation of nationals abroad in the implementation of outlined national development programs.

In related news, on April 21 and 27, respectively, Mr. Negasi Kassa, the ambassador of Eritrea

to the EU and Benelux Countries, gave seminars for citizens living in Amsterdam and Sullen.

During these seminars, Ambassador Negasi provided extensive briefings on the national development programs outlined for 2024 and beyond, Eritrea's foreign policy, and the significance of strong organizational capacity in implementing national programs. These topics were of great relevance and importance to the Eritrean diaspora.

Mr. Kibreab Tewolde, Head of Consular Affairs, and Mr. Isaac Minassie, Head of Public and Community Affairs, also provided extensive briefings on consular services and public diplomacy activities.

Likewise, Sweden's National Union of Eritrean Women branch organized a virtual annual activity assessment meeting via webinar on 27 April. Ms. Saba Tekle, Head of the branch union, underscored the heroic role of Eritrean women in achieving independence, safeguarding sovereignty, and preserving national values and identity, calling for its sustainability. Participants, including the Head of the Public and Community Affairs

branch in the Embassy of Eritrea in Scandinavian countries, discussed observed strengths and weaknesses.

Similarly, in the US, nationals residing in Columbus and its environs in Ohio State and Indianapolis conducted a celebration under the theme "Fenkil against all odds and challenges." During the occasion, Mr. Berhane Gebrehiwet, Charge d'Affairs of the Eritrean Embassy in the USA, presented a seminar titled "Current Opportunities and Challenges.

Press Statement

The Embassy of the State of Eritrea to the Swiss Confederation is appalled by the provocative contents of a letter dated 17th April 2024 about Eritrea's Independence Day as well as the normative annual celebrations associated with this honorable event.

The Embassy wishes to remind the Swiss authorities that 24 May 1991 marks the historic liberation of Eritrea after a thirty-year costly war against colonial occupation and that had exacted the unparalleled and precious sacrifices of over 60,000 Eritrean freedom fighters in the context of a small nation.

The people of Eritrea resorted to armed struggle in 1961 when their inalienable rights to nation-hood in the period of decolonization was trampled through a US-sponsored UN Resolution 390 A (V) that bound their country to Ethiopia for "overriding US Strategic interests". Ethiopia went further to unilaterally abrogate, with impunity, the Federal Act and annex Eritrea in 1962.

Eritrea's hard-won military victory on 24 May 1991 paved the way for the people of Eritrea to hold a referendum to illustrate to the wider world, their aspirations for national independence and dignity.

In April 1993, Eritreans inside Eritrea and across the globe cast

their vote in a UN-sponsored referendum to decide whether or not they wanted Eritrea to be a sovereign state. The people of Eritrea voted with an overwhelming majority of 99.8% in favor of sovereignty.

In the immediate aftermath of the historic referendum, Eritrea acceded to and assumed its seat at the United Nations alongside countries like Switzerland. Eritrea also established bilateral diplomatic ties with the community of sovereign nations as well as important regional and international organizations.

In the event, feigning ignorance of these historical events to desecrate Eritrea's National Day is an irresponsible, reprehensible and unacceptable act of political and legal blasphemy of the highest order. The Embassy of Eritrea requests immediate rescinding of the letter and appropriate remedial action.

Naturally, Eritreans at home and abroad have and continue

to celebrate Independence Day in unison and with vigorous vibrancy as it symbolizes the day that so many have sacrificed so much to ascertain their inalienable national rights and human dignity.

In this perspective, the 24 May Eritrean independence celebrations which have been held in Switzerland, Europe and other parts of the World in the past three decades have always been peaceful family events. These events have been attended by all sections of the Eritrean community.

It is very unfortunate that since last year, a violent group claiming to be "Eritreans and fighting for the rights of Eritreans" have tried to disrupt the traditionally peaceful Eritrean Independence Day celebrations. These are naturally illicit acts of vandalism and threats to public safety that have to be dealt with in accordance with the law.

On the other hand, to appease

these violent thugs, or use their illicit conduct to prevent law-abiding Eritreans in Switzerland from celebrating Independence Day peacefully and with civility – as this has indeed been the normative tradition – cannot be justifiable under any

circumstances.

The two-hour event featured performances from cultural troupes such as Aser, Kewakibti Rim, and Meras and a comedic act by Dawit Eyob and his team.



Britrea's Presentations on progress in Health and Education to the UPR Session

Right to Health

- The government has maintained a continuous focus on improving access to and quality of healthcare in the country for the last three decades. In close cooperation with development partners, health is now a guaranteed fundamental right in Eritrea. This was done essentially through universalization, affordability and enhancing modern medical infrastructure.
- The Ministry of Health (MoH) conducted a Third National Health Policy review and has developed the Third Health Service Sector Development Program 2022-2026. Essential health care packages that are vital tools for attaining universal access to quality health care, and increasing equitable distribution of health care services. Current government programs policies remain aligned with the 2030 SDGs on Universal Health Coverage.
- During the reporting Eritrea has made period, substantial investments in its Public Health System. These investments in conjunction with other developmental programs have resulted in continuous improvements which have narrowed the health protection gaps.
- Eritrea has come a long way in improving maternal and newborn health. The under-five mortality rate, for example, has steadily declined from 153 deaths per 1000 live births in 1990 to 37 in 2022, registering a remarkable 76% reduction.
- Routine childhood

health intervention that helps prevent serious illness, disability, and death in children. Eritrea's tremendous leaps in routine childhood vaccination have garnered recognition and multiple awards from various regional/ global organizations in the past two decades. Universal immunization has been sustained in Eritrea at around 98% since 2013.

- The MoH has been constructing maternity waiting homes in health facilities for pregnant women who live far from health facilities. Hence, delivery at health facilities reached 83.7% in 2023 from only 6% in 1991.
- During the reporting period, there has been a marked expansion of healthcare services. The national health infrastructure has increased 3.7-fold from 93 in 1991 to 347 as of December 2023. By complementing this with an elaborate network of all-weather rural roads, 70% of the population now lives within a 5 km radius of a functioning health facility.

Patients are required to make only nominal payments. It is free for those who need financial help. Public and preventive services, such as immunization and growth monitoring, nutrition and supplementation, and health education, are free of charge. Patients with chronic diseases and other disorders, such as TB, HIV/ AIDS, hypertension, diabetes, and mental disorders, are provided medicaments free of charge.

- Prevention Infection and Control (IPC) has rolled out nationally, with IPC and Medicines Therapeutic Committees (MTCs) established in each hospital. The proportion of fully or partially completed test samples has steadily increased and stands at 98% since 2019.
- The national disease burden has shifted from Communicable diseases to non-Communicable Diseases. As is the trend globally, cardiovascular diseases, diabetes, and cancer have become the leading cause of morbidity and mortality in Eritrea. To combat these diseases Eritrea has developed an MNCD Five Year Strategic Plan and policy in 2019.
- In a nutshell, disease remedy and prevention have increased manifold, disease incidence decreased significantly and the average life expectance of the people stood at 67.7 in 2023 with almost 20 years increase from that of 1991.

Right to Education

Education is a high priority in Eritrea. The greatest wealth of our nation is the people. Education is key to lasting peace, sustainable development and the eradication of poverty. Education is a fundamental human right of which nobody should be deprived.

- We believe that education is a key ingredient in realizing human rights. Under the motto 'education for all', education in Eritrea is universal and free from kindergarten to tertiary level. Primary education is mandatory.
- In Eritrea, the literacy rate now stands at 85% and efforts are well underway to make it 100% in the near future. Eritrea managed to implement this through the construction of new schools, reviewing curriculum and enhancing the capacity of teachers.
- To ensure equitable access to quality education in remote and hard-to-reach areas, the government introduced Complementary Elementary Education (CEE) and nomadic education. Education is key to the advancement of women. The government is committed to empowering girls' education and reducing gender disparity to improve access to education for girls at all levels. With various schemes, retention rates among female students have increased significantly. Female students, particularly those within the nomadic community, receive both financial and non-financial support; particularly in order to assist them in managing their household duties while pursuing their education.
- These schemes involved, providing educational material, opening hostels or boarding schools in rural and remote areas, and improving accessibility through initiatives like providing bicycles for girls who travel long distances to schools. Currently, there are a total of 65 schools dedicated to the nomadic community; with 10 of them being boarding schools. Additionally, feeding programs are being implemented in remote and disadvantaged areas to attract out-of-school children and ensure they have full access to education.

The USA is known for its iced tea. Eighty percent of tea is consumed as iced tea over there. I can go on and on. I haven't even mentioned India and its Chai's, or Iran, Afghanistan and the Middle East, in general, where tea ceremony is almost like a religious ceremony to behold.

My favorite tea ceremony (which I hope we can adopt here in our own country) has to be Mali's. You see, in Mali, gunpowder tea is served in three rounds. It starts with the strongest, unsweetened tea, locally referred to as "strong like death", followed by a second serving, in which the same tea leaves are boiled again with some sugar added. Safeguarding the Safety and Health of **Workers and Work Place** of workers and women as one Simon Weldemichael

International Safety Day was observed in Eritrea for the first time on 28th April under the theme "Safeguarding the safety and health of workers and work place is a collective responsibility." In connection with the event, the Ministry of Labor and Social Welfare released a statement that underscores the importance of safety of workers and workplace. The statement reminds everyone that the safety of work place and the safety and health of workers can be ensured by the collective contribution of workers, employers, and relevant government bodies.

Work place accidents have caused enormous human and socioeconomic problems. According to reports of the International Labor Organization (ILO), 6,300 workers die every day due to accidents in workplace and diseases related to the work environment.

The Labor Proclamation of Eritrea, which was enacted in 2001, defines the rights and obligations of workers and employers in the workplace. It embodies a vision of universal and humane conditions of labor to attain social justice and decent work place, articles that aim to protect workers from being harmed or killed at work, and requires employers to provide their employees with working conditions that are free from dangers

Labor Proclamation The of Eritrea gives weight to the fundamental rights at work, which are stated in 162 articles. The fundamental rights include the freedom of association and the right to organize (Article 86), the right to bargain a collective agreement (Article 99), criminalizing forced labor (Article 9), the prohibition of workplace discrimination and working conditions for women (Article 65), and equal pay for the same type of work (Article 41). The proclamation also makes provisions for employment and training, remuneration, working hours and rest periods, workplace health and safety and social security.

Article 20 of the Labor Proclamation is devoted entirely to the obligations of an employer. According to the article, an employer has to respect the employee's dignity and take all the necessary occupational safety and health measures. In instances of

accidents or work related diseases the employer has to bear the cost of medical examination, whenever such medical examination is appliances and devices provided. A worker is under obligation to use the safety appliances and must not misuse any appliance or other as well. Their participation in the liberation struggle helped transform the technical and organizational capacity of the Eritrean revolution. The EPLF, as a vanguard liberation organization, took the lead in forming associations of workers, peasants, women, students as well as professionals. The workers association was formed at a national level in 1979 during the struggle for independence. Following Eritrea's independence, it was renamed the National Confederation of Eritrean Workers, which today is one of the most prominent civil societies in the country.

The government's commitment to do all that it can for the welfare of workers has been demonstrated throughout its history. When the

of the eleven objectives. This was reiterated at the second organizational congress in 1987.

Workers are human beings with rights, needs and aspirations, and they need laws and regulations to protect their dignity, security and freedom. Article 2187 of the civil code of Eritrea requires the employer to "respect the employee's dignity." It also states that "the employer shall not discriminate against a person with regard to employment or wages solely because of that person's race, color, nationality, language, sex, religion, lineage, pregnancy, marital status, family responsibility, disability, political orientation or economic or social status." In relation to health and safety, Art. 2190 of the civil code requires an employer to take steps to ensure the health and safety of the employees. The employer shall bear the cost of a medical examination and shall provide the employee with personal protective equipment.

It's significant and worthwhile to mention the substantial efforts that Eritrea has made to ensure the health and safety of workers and work place. However, safety and health of workplace still remain a concern. Private and public companies must continue to enhance and implement the Labor Proclamation of Eritrea strictly to ensure the safety and health of workers and create injury-free and productive workplaces.

International Safety Day was observed worldwide for the 21st time on 28th April under the theme "Ensuring safety and health at work in a changing climate" to promote the prevention of occupational accidents and diseases.

And it is the employer's responsibility "to provide employees with personal protective equipment and other necessary materials and instruct them on their use."

Article 21 deals with the obligations of an Employee to maximize safety. An employee has the obligation to implement all health and safety instructions issued by an employer or by a concerned authority and to utilize appropriately and with care

"From the point of view of justice, the opinion of the Eritrean people must receive consideration. Nevertheless, the strategic interests of the United States in the Red Sea Basin and world peace make it necessary that the country be linked with our ally Ethiopia." The former American Secretary of State John Foster Dulles thus resolved the question of Eritrean Independence, for the pursuit of "prevalent geostrategic interests", at the end of the 1940s, when the fate of Italy's former colonies - and as a corollary Eritrea's right to decolonization-was addressed by the United Nations. Almost eighty years later, small Eritrea has conducted its war of liberation for thirty years, in almost total isolation, against occupiers – whether monarchists or military dictators - supported transversely, among others by the United States and the USSR.

Today one of the most stable countries in Africa, strategically overlooking the Red Sea along its 1,200 kilometers of coastline,

Eritrea does not look to the past with a rancorous and retrograde mentality, but is ready to take on the challenges of the global era.

Moreover, when its President Isaias Afwerki met our Prime Minister Giorgia Meloni, for the first time in January, the discussion was all-rounded. From bilateral ties, to mutual cooperation and investment opportunities that this pristine land offers in the sectors of roads, railways, ports, cable transport, agriculture, innovation, fish resources, energy. Because still today the bond that unites us with Eritrea is extraordinary. Just a walk along the central street of Asmara, from the cathedral of the Blessed Virgin of the Rosary, to the Cinema Roma make to realize this. It feels like a being in EUR, Sabaudia or Latina, surrounded by that rationalist architecture, still intact and preserved. "Eritrea remains an oasis of peace in a rather turbulent region, often tormented religious fundamentalists institutionalized ethnic polarity", the Eritrean Minister of Information rightly recalled the other day, speaking from Asmara at Lumsa University (Libera

Universita Maria SS. Assunta, often simply abbreviated as "LUMSA"). "This is thanks to its policies and cultural orientation".

The memory of Italy, of all the good it has done remains strong and rooted. In culture, in religious practices, in buildings. Every day (weekdays) two masses in Italian, at 7 in the morning and at 5 in the afternoon, celebrated and attended in our language especially by Eritrean women and men

In addition, every time you travel from Asmara to Massawa, along the 110 kilometers of road that descends from 2,400 meters to sea level, alongside the narrowgauge railway built by us Italians, whosoever accompanies you, is keen to remember, "You build it and the English took it away from us". Eritrea yesterday and today, which tomorrow is preparing to sign important agreements with Italy. Also thanks to Ambassador Marco Mancini. Already starting from June, when one of our most important economic ministers will travel to that land to implement the Mattei Plan. INTERNATIONAL DAY FOR PLANT HEALTH OBSERVED AT THE NATIONAL LEVEL

The International Day for Plant Health, celebrated globally on May 12th, was observed in Asmara under the theme: Plant Health, Safe Trade, and Digital Technology. The Ministry of Agriculture (MoA) organized the event at the National Confederation of Eritrean Workers' headquarters on May

ceremony featured The representatives from various including ministries, sectors, administrations, regional national associations, educational institutions, and Eritrea's Food and Agriculture Organization office. Agriculture stakeholders, experts, farmers also participated.

Mr. Tekleab Mesgena, Director General of the Regulatory Services Department at the MoA,

delivered a keynote address at the event. He emphasized the critical relationship between plant health and human health, food safety, and oxygen production. Mr. Tekleab also detailed the challenges posed by international trade and the MoA's collaboration with the International Plant Protection Convention (IPPC) to enhance national plant quarantine capacities and standardize phytosanitary measures,

including the adoption of a global digital certification system.

Despite progress, Mr. Tekleab acknowledged gaps in meeting international standards, emphasizing plant health as a central focus of the MoA's Strategic Plan for 2024-2028.

Mr. Asgedom Tewelde, representing the FAO, reported that up to 40% of global crops

are lost annually to plant pests and diseases, costing about USD 220 billion. He stressed the importance of plant health for food security, environmental safety, and maintaining biological diversity. Mr. Asgedom urged a collective effort among government bodies, the private sector, farmers, IPPC Contracting Parties, and the scientific community to promote safe trade practices.

featured event presentations on various topics, including bio-pesticide production, the role of digital technology in plant health, and laboratory enhancements for plant health. These discussions led to important outcomes such as the focus on bio-pesticide commercialization, updating the National Pest List, and improving public awareness about pesticide use, all of which are crucial for plant health and safe trade.

A panel discussion further addressed these issues, emphasizing the importance of preventing illegal pesticide importation. The celebration marked the third observance of the International Day for Plant Health, highlighting its significance in promoting public awareness globally and nationally.
